





Lizenzänderungen: Autor*innen anschreiben (Elsevier)

Dear author,

You have recently published your article [Titel], DOI xxxxx, in [Journal-Titel] open access under the german-wide DEAL agreement with Elsevier. In the process, you have sadly selected a license that restricts the reuse of your work (CC BY-NC / ND / NC-ND). The Alliance of German Science Organisations recommends using the Creative Commons licence CC BY for scientific publications. CC BY is the most liberal type of licence, allowing the widest possible reuse of your work and ensuring that you are credited as the author of the original. The choice of "non-commercial" CC BY-NC/ NC-ND licences is not recommended, as it limits the possibilities of distribution and publishers must be granted a commercial use right by the CC licence, and this is usually exclusive, so that permission for commercial use by others, even by authors, requires the publisher's permission. Hence as an author you should always choose CC BY without any restricting attribution if possible. The good news is that you have the possibility to retroactively choose the recommended CC BY license for your article above. To do so, please contact osasupport@elsevier.com and request the change to CC BY. After you have confirmed the license, Elsevier will update your article accordingly.
